FISHERY TYPE: SUBSISTENCE

SPECIES: GOOSE BARNACLE (*Pollicipes polymerus*), MUSSEL (*Mytilus spp.*), LIMPETS, CHITONS, SEAWEEDS.

ON/OFF RESERVATION: OFF

EFFECTIVE DATES: FEBRUARY 1, 2022 THROUGH JANUARY 31, 2023.

DAYS AND HOURS: FOR THE PORT GAMBLE S'KLALLAM AND JAMESTOWN S'KLALLAM TRIBES, ALL CATCH AREAS: OPEN THURSDAY, FEBRUARY 10, 2022 THROUGH TUESDAY, JANUARY 31, 2023.

OTHER RESTRICTIONS:

1. THE DAILY SUBSISTENCE HARVEST LIMIT FOR ALL CATCH REPORTING AREAS AND SHELLFISH SPECIES COMBINED IS 15 POUNDS PER FISHER.
2. THE DAILY SUBSISTENCE HARVEST LIMIT FOR ALL CATCH REPORTING AREAS AND SEAWEED SPECIES COMBINED IS 15 POUNDS PER HARVESTER.
3. THERE ARE NO SIZE LIMITS FOR HARVESTABLE ANIMALS AND SEAWEEDS IN THIS FISHERY.
4. HARVEST OF SEAWEEDS IS RESTRICTED TO USE OF HANDHELD TOOLS

CATCH REPORTING:

ALL TRIBAL SUBSISTENCE FISHERS MUST REPORT THEIR CATCH TO THEIR RESPECTIVE FISHERIES OFFICE IN ACCORDANCE WITH THE REQUIREMENTS OF THE RESPECTIVE CATCH REPORTING CARDS OR PERMITS. SUBSISTENCE FISHERS MUST HAVE DOCUMENTATION OF REGISTRATION ON THEIR PERSON WHEN FISHING.
