SPECIES: SPOT SHRIMP (*Pandalus platyceros*), MANILA & LITTLENECK CLAMS, OYSTERS AND COCKLES.

1. FOR SPOT SHRIMP: OPEN FOR CATCH AREA 27A FROM 7:00 AM THROUGH 5:00 PM THURSDAY, MAY 11.
2. FOR MANILA AND LITTLENECK CLAMS: OPEN FOR WOLFE PROPERTY SP (250510) FROM 1:30 PM THROUGH 6:30 PM THURSDAY, MAY 11.
3. FOR OYSTERS: OPEN FOR WOLFE PROPERTY SP (250510) FROM 1:30 PM THROUGH 6:30 PM THURSDAY, MAY 11.
4. FOR COCKLES: OPEN FOR SEQUIM BAY SP NORTH (250055), SEQUIM BAY SP SOUTH (250050) AND ANDERSON LANDING (270412) FROM 12:30 PM THROUGH 6:30 PM THURSDAY, MAY 11.

HARVEST RESTRICTIONS:

1. THIS FISHERY WILL BE CONDUCTED BY THE PORT GAMBLE S'KLALLAM TRIBE ONLY.
2. CLAM, OYSTER AND COCKLE HARVESTERS MAY INCLUDE:  
HEATHER SULLIVAN, KATHERINE SULLIVAN, MATTHEW IVES, PAUL HEBERT JR., TANNER SULLIVAN-CHEYNEY, RYAN SULLIVAN, JALEENA WOODRUFF, CHRIS SULLIVAN, RICKY SULLIVAN, ROGER SULLIVAN SR., ROGER SULLIVAN JR. AND DONALD SULLIVAN.
3. ONE BOAT WILL PARTICIPATE IN THE SHRIMP FISHERY. THE FISHER WILL BE RICKY SULLIVAN, VESSEL ID# WN-675-PGK.

4. THE TARGET HARVEST FOR THIS FISHERY IS 40 POUNDS OF SHRIMP, 60 POUNDS OF CLAMS, 10 DOZEN OYSTERS AND 45 POUNDS OF COCKLES.

2. THE MAXIMUM ALLOWABLE TOTAL NUMBER OF POTS FOR THIS FISHERY IS 15 SHRIMP POTS.

ALL CEREMONIAL CATCHES SHALL BE REPORTED TO THE PORT GAMBLE FISHERIES OFFICE AFTER CLOSURE OF THE FISHERY.
