AREAS 12/12B: OPEN MONDAY (09/16) THROUGH FRIDAY (9/20); AND

AREA 12: SUNDAY (09/22) THROUGH THURSDAY (10/10), OPEN SUNDAY THROUGH THURSDAY EACH WEEK;

AREA 12B: SUNDAY (09/22) THROUGH THURSDAY (10/17), OPEN SUNDAY THROUGH THURSDAY EACH WEEK;

OTHER RESTRICTIONS:

1. AS PER REG. #F24-024.
2. ALL CHUM AND CHINOOK CAUGHT MUST BE RELEASED UNHARMED THROUGH (9/30).
3. ALL CATCH MUST BE REPORTED ON FISH TICKETS OR ROADSIDE SALE REPORTING FORMS.
4. WESTERN SHORE OF AREA 12B (FROM THE SHORELINE TO 500 FEET OFFSHORE) IS CLOSED TO BEACH SEINES OCTOBER 1 THROUGH OCTOBER 10.
5. BEACH SEINE GEAR MAY NOT BE OPERATED CLOSER THAN 1000 FEET FROM ANY STREAM OR RIVER MOUTH THAT IS CLOSED TO NET FISHING.
6. BIG BEEF CREEK, BEACH SEINES MAY NOT BE OPERATED CLOSER THAN 1500 FEET FROM THE SEABECK HIGHWAY BRIDGE.
7. BEACH SEINES MUST HAVE ONE END ON THE BEACH WHILE BEING FISHED.
8. PORT GAMBLE S'KLALLAM FISHERS MUST REGISTER WITH THEIR NATURAL RESOURCES OFFICE PRIOR TO PARTICIPATING IN THE FISHERY.

JUSTIFICATION: HARVEST AVAILABLE COHO SALMON.
