OTHER RESTRICTIONS:

1. AS PER REG. #F24-024.
2. WESTERN SHORE OF AREA 12B (FROM THE SHORELINE TO 500 FEET OFFSHORE) IS CLOSED OCTOBER 1 THROUGH OCTOBER 10.
3. ALL CATCH MUST BE REPORTED ON FISH TICKETS OR ROADSIDE SALES FORMS.
4. ALL CATCH MUST BE MADE AVAILABLE TO JAMESTOWN OR PORT GAMBLE FISHERIES STAFF FOR SAMPLING PURPOSES.
5. ALL SALMON CARCASSES MUST BE REMOVED FROM THE WATER AND FROM THE BEACH.
6. GILLNET GEAR MAY NOT BE OPERATED CLOSER THAN 1000 FEET FROM ANY STREAM OR RIVER MOUTH THAT IS NOT OPEN TO NET FISHING.
7. BIG BEEF CREEK, GILLNETS MAY NOT BE OPERATED CLOSER THAN 1500 FEET FROM THE SEABECK HIGHWAY BRIDGE.
8. PORT GAMBLE S'KLALLAM FISHERS MUST REGISTER WITH THEIR NATURAL RESOURCES OFFICE PRIOR TO PARTICIPATING IN THE FISHERY.

JUSTIFICATION: HARVEST AVAILABLE COHO SALMON.
