DAYS/HOURS: OPEN TUESDAY (09/07), FROM 8:00 AM TO 2:00 PM (6 HR FISHERY)

OTHER RESTRICTIONS:

1. AS PER REG. #F21-021.
2. ALL CHINOOK AND CHUM SALMON MUST BE RELEASED UNHARMED.
3. ACCESS TO THIS FISHERY IS RESTRICTED TO THE DESIGNATED TRAIL TO THE POOL AREA.
4. ACCESS IS PROHIBITED THROUGH THE RIPRAP AREA OR ANY HATCHERY STRUCTURES.
5. DUE TO THE INSTABILITY OF THE BOULDERS AND ROCKS, ACCESS IS NOT PERMITTED ON THE ROCKS LOCATED ON THE NORTHERLY/WESTERLY SIDE OF THE RIVER BELOW THE ROAD LEADING TO THE HATCHERY AND ON THE SIDE OF THE RIVER THE HATCHERY IS LOCATED.
6. PARKING IS PROVIDED ON THE RIGHT SIDE OF HATCHERY ACCESS ROAD (NEAR BARBED-WIRE FENCE).
7. NO LITTER, FISH, OR FISH PARTS MAY BE LEFT BEHIND AFTER THE FISHERY CLOSES. ANY VIOLATION OF THIS PROVISION IS A CITABLE OFFENSE UNDER THE "LITTERING PROHIBITED" PROVISION OF THE TRIBAL FISHING ORDINANCE.
8. ALL CATCH MUST BE REPORTED ON FISH TICKETS.
9. ALL FISHERS MUST RECORD "ROADSIDE" FISH SALES ON ROADSIDE SALES FORMS.

10. ALL CATCHES MUST BE MADE AVAILABLE FOR FISHERIES STAFF OR USFWS FOR SAMPLING PURPOSES.
11. FISHERS ARE REMINDED THAT WHEN USING POLE GAFFS AND TREBLE HOOKS TO BE AWARE OF SURROUNDING FISHERS IN ORDER TO REDUCE INCIDENTAL BODILY HARM.
12. THIS OPENING IS FOR THE PORT GAMBLE S'KLALLAM TRIBE ONLY.
