OTHER RESTRICTIONS: AS PER REG. #F21-049.

THE FOLLOWING RESTRICTIONS SHALL BE IN EFFECT:

1. DAILY ROTATION IS REQUIRED FOR POSITIONS.

ROTATION IS ONE SET DOWNSTREAM DAILY AT 3:00 PM.
THERE IS A TWO-HOUR GRACE PERIOD TO RETAIN A FISHER'S
SPOT. IF THERE ARE UNOCCUPIED SITES AFTER THE TWO
HOUR GRACE PERIOD, ONLY THE NEXT FISHER IN ROTATION
MAY MOVE DOWN INTO A VACANT SPOT.

FISHERS WHO WERE NOT AT THE LOTTERY BUT WISH TO FISH
THE SEASON, WILL BE PLACED AT THE UPSTREAM END OF THE
OCCUPIED SITES.

2. FISHER MUST FISH AT LEAST FOUR HOURS TO KEEP SPOT IN
ROTATION.

3. ONLY ONE NET MAY BE FISHED BY EACH FISHER. NETS MUST BE CHECKED AT LEAST EVERY 12 HOURS DURING THE FISHERY.
4. BOTH ENDS OF THE NET MUST BE CLEARLY MARKED WITH THE FISHERS NAME AND TRIBE.
5. SETTING, ATTENDING, OR REMOVING ANOTHER FISHERS GEAR IS PROHIBITED.
