SPECIES: DUNGENESS CRAB (*Metacarcinus magister*), SPOT SHRIMP (*Pandalus platyceros*), MANILA & LITTLENECK CLAMS.

EFFECTIVE DATES: JULY 21 THROUGH 22, 2021

DAYS/HOURS:

1. FOR DUNGENESS CRAB: OPEN FOR CATCH AREAS 25C AND 27A AT 7:00 AM THURSDAY, JULY 22, CLOSE 8:00 PM THURSDAY, JULY 22.
2. FOR SPOT SHRIMP: OPEN FOR CATCH AREA 25E AT 7:00 AM WEDNESDAY, JULY 21, CLOSE 8:00 PM WEDNESDAY, JULY 21.
3. FOR MANILA AND LITTLENECK CLAMS: OPEN FOR WOLFE PROPERTY SP (250510) AT 7:30 AM THURSDAY, JULY 22, CLOSE 11:30 AM THURSDAY, JULY 22.

HARVEST RESTRICTIONS:

1. THIS FISHERY WILL BE CONDUCTED BY THE PORT GAMBLE S'KLALLAM TRIBE ONLY.
2. CLAM HARVESTERS WILL INCLUDE BILL IVES, CHRISTINA CHARLES, RON CHARLES AND OTHERS AS DESIGNATED BY PORT GAMBLE NATURAL RESOURCES STAFF.
3. ONE BOAT WILL PARTICIPATE IN THE SHRIMP AND CRAB FISHERIES. THE FISHER WILL BE BILL IVES, VESSEL ID# WN-611-PGK.
4. THE TARGET HARVEST FOR THIS FISHERY IS 50 POUNDS OF CRAB, 30 POUNDS OF SHRIMP AND 60 POUNDS OF CLAMS.

LEGAL GEAR:

1. AS PER REGULATIONS #S21-055 SECTIONS 7 & 8, #S21-021 SECTION 5, #S21-002 SECTION 4.
2. THE MAXIMUM ALLOWABLE TOTAL NUMBER OF POTS FOR THIS FISHERY IS 15 CRAB POTS AND 15 SHRIMP POTS.

CATCH REPORTING:

ALL CEREMONIAL CATCHES SHALL BE REPORTED TO THE PORT GAMBLE FISHERIES OFFICE AFTER CLOSURE OF THE FISHERY.

JUSTIFICATION:

HARVEST FOR CEREMONIAL NEEDS. THIS REGULATION CHANGES THE HARVEST DATE FOR FOR THE CRAB AND CLAM OPENINGS TO THURSDAY, JULY 22.
