CATCH AREAS: SHRIMP MANAGEMENT REGION 3,
CATCH REPORTING AREA 25E AND THAT PORTION OF AREA 25A WITHIN
SHRIMP DISTRICT #1.

FISHERY TYPE: COMMERCIAL

SPECIES: SPOT SHRIMP (*Pandalus platycerus*)

ON/OFF RESERVATION: OFF

EFFECTIVE DATES: AUGUST 1 THROUGH SEPTEMBER 15, 2022

DAYS/HOURS: FOR THE PORT GAMBLE S'KLALLAM TRIBE ONLY, THIS FISHERY IS OPEN
FROM 8:00 AM MONDAY, AUGUST 1 THROUGH 6:00 PM THURSDAY,
SEPTEMBER 15, OR UNTIL THE TARGET HARVEST HAS BEEN TAKEN,
WHICHEVER COMES FIRST.

GEAR RESTRICTIONS:

1. AS PER REGULATION #S22-024, SECTION 5
2. THE MAXIMUM ALLOWABLE TOTAL NUMBER OF POTS AND/OR RING NETS COMBINED, IS 15 POTS PER FISHER. SHRIMP POTS REGISTERED TO A PARTICULAR VESSEL MUST BE SET AND PULLED BY THAT VESSEL, UNLESS OTHERWISE APPROVED BY THE RESPECTIVE TRIBAL FISHERIES OFFICE.
3. THE MINIMUM MESH SIZE FOR SHRIMP POTS AND RING NETS IS ONE INCH, AS DEFINED IN REGULATION #S22-024, SECTION 5, EXCEPT FOR FLEXIBLE (WEB) MESH POTS, FOR WHICH THE MESH MUST BE A MINIMUM OF 1 3/4 INCH STRETCH MEASURE. THERE IS NO MINIMUM MESH SIZE FOR ENTRY TUNNELS, BUT TUNNELS CAN ONLY BE LOCATED ON THE SIDES OF THE POTS.
4. LONG LINES ARE ALLOWED IN THE DISTRICT #1 SHRIMP FISHERY, PROVIDED THAT ALL LONG LINES AS WELL AS SINGLE POTS AND RING NETS SHALL HAVE BUOYS ATTACHED. BUOYS SHALL BE ANY COLOR EXCEPT YELLOW OR A COMBINATION OF RED AND WHITE. EACH BUOY SHALL BE CONSPICUOUSLY MARKED WITH THE INITIALS OF THE FISHER'S TRIBE FOLLOWED BY THE FISHER'S ID NUMBER. THE BUOY SHALL ALSO BE MARKED WITH THE NUMBER OF POTS ATTACHED. EACH BUOY SHALL BE MARKED IN SUCH A WAY THAT THE

FISHER, TRIBAL AFFILIATION AND NUMBER OF ATTACHED POTS CAN BE IDENTIFIED WITHOUT REMOVING THE GEAR FROM THE WATER.

HARVEST RESTRICTIONS:

1. EACH FISHER PARTICIPATING IN THE DISCOVERY BAY FISHERY MUST BE CHOSEN BY LOTTERY BY THE PORT GAMBLE FISHERIES OFFICE. EACH FISHER WILL BE RESTRICTED TO A TOTAL HARVEST OF 142 POUNDS OF SHRIMP.
2. EACH FISHER MUST BE IN POSSESSION OF A PERMIT ISSUED FROM THE PORT GAMBLE FISHERIES OFFICE. EACH PERMIT WILL AUTHORIZE FISHING FOR A SINGLE 24 HOUR PERIOD ONLY, ON A SPECIFIED DATE. OVERNIGHT SOAKS ARE PERMITTED.

HARVEST REPORTING:

1. AS PER REGULATION #S22-024, SECTION 8.
2. ALL DAILY HARVEST INFORMATION WILL BE REPORTED TO THE RESPECTIVE TRIBAL FISHERIES OFFICE WITHIN 24 HOURS OF EACH HARVEST. HARVEST INFORMATION SHALL INCLUDE THE DATE, VESSEL NAME, NUMBER OF POTS, MESH SIZE, POT SOAK TIMES, CATCH AREA, LOCATION FISHED, POUNDS LANDED BY SPECIES AND TOTAL POUNDS LANDED. HARVEST INFORMATION WILL BE UPLOADED ON THE NWIFC TICKET DATABASE WITHIN 7 DAYS OF REPORTING.
3. ALL COMMERCIAL AND SUBSISTENCE CATCHES SHALL BE REPORTED ON TREATY INDIAN FISH RECEIVING TICKETS AS SPECIFIED IN TRIBAL FISHERIES ORDINANCES. ALSO, ALL COMMERCIAL SHRIMP POT LANDINGS MUST BE RECORDED ON RECEIVING TICKETS AS WHOLE WEIGHT.
4. ALL COMMERCIAL SHRIMP SALES INTENDED FOR RESALE MUST BE MADE TO TRIBALLY APPROVED BUYERS WHO HAVE FILLED OUT A BUYER'S AGREEMENT WITH PORT GAMBLE S'KLALLAM TRIBE.

JUSTIFICATION:

COMMENCE COMMERCIAL HARVEST OF THE TREATY SHARE OF SHRIMP IN THE STIPULATED MANAGEMENT AREAS OF REGION 3.
