

POINT NO POINT SECTION 4.6 SHRIMP REGULATION FOR REGIONS 1, 2W & 3

The following regulation is promulgated by the Point No Point Treaty Council and shall govern the commercial shrimp fisheries conducted off-reservation and on subtidal public lands by the Port Gamble S'Klallam and the Jamestown S'Klallam Tribes (PNPTC member Tribes). The term of this regulation is from March 1, 2024 through February 28, 2025, and is intended to regulate harvest by these member Tribes in shrimp management regions 1, 2W and 3 under provisions of Paragraph 4.6 of the U.S. District Court Order of August 28, 1995 (Implementation Order) in U.S. v Washington, Sub-proceeding 89-3. In the event the regions 1, 2W and 3 shrimp management plans are completed before the end of this regulation term, this regulation will be superseded by a new regulation conforming to the provisions of the regions 1, 2W and 3 shrimp harvest management plans.

CATCH AREAS: SHRIMP MANAGEMENT REGION 1,
CATCH AREA 1A (AREA 20B WEST OF A LINE FROM POINT DOUGHTY ON ORCAS ISLAND TO THE BELL BUOY ON THE INTERNATIONAL BORDER, AND ALL WATERS OF AREA 22A WEST OF A LINE PROJECTED TRUE NORTH AND SOUTH THROUGH THE WESTERN TIP OF CRANE ISLAND, WEST OF A LINE PROJECTED FROM THE NUMBER 2 BUOY AT FISHERMANS BAY ON LOPEZ ISLAND TO THE SOUTHERN TIP OF SHAW ISLAND, AND WEST OF A LINE PROJECTED DUE SOUTH FROM POINT COLVILLE EXCEPT THAT PORTION OF 22A SOUTH OF A LINE FROM LIMEKILN POINT DUE WEST TO THE INTERNATIONAL BOUNDARY AND SOUTH OF SAN JUAN AND LOPEZ ISLANDS AND A LINE FROM CATTLE POINT TO DAVIS POINT),

CATCH AREA 1B (AREA 20B EAST OF A LINE FROM POINT DOUGHTY ON ORCAS ISLAND TO THE BELL BUOY ON THE INTERNATIONAL BORDER, AND ALL WATERS OF AREA 22A EAST OF A LINE PROJECTED TRUE NORTH AND SOUTH THROUGH THE WESTERN TIP OF CRANE ISLAND, EAST OF A LINE PROJECTED FROM THE NUMBER 2 BUOY AT FISHERMANS BAY ON LOPEZ ISLAND TO THE SOUTHERN TIP OF SHAW ISLAND, AND EAST OF A LINE PROJECTED TRUE SOUTH FROM POINT COLVILLE);

SHRIMP MANAGEMENT REGION 2 WEST, CATCH REPORTING AREAS 25B, 25C, 25D, AND ALL S'KLALLAM U&A IN THAT PORTION OF 26A SOUTH AND WEST OF THE SOUTHERN TIP OF POSSESSION POINT ON WHIDBEY ISLAND;

SHRIMP MANAGEMENT REGION 3,
CATCH AREA 23A EAST (THOSE WATERS OF AREA 23A AND THE DESCRIBED PORTION OF AREA 22A NORTH OF A LINE PROJECTED 48.22.50' DEGREES NORTH LATITUDE, AND EAST OF A LINE PROJECTED 122.57 DEGREES WEST LONGITUDE),

CATCH AREA 23A WEST (THOSE WATERS OF AREA 23A AND THE DESCRIBED PORTION OF AREA 22A NORTH OF A LINE PROJECTED 48.22.50' DEGREES NORTH LATITUDE, AND WEST OF A LINE PROJECTED 122.57 DEGREES WEST LONGITUDE).

FISHERY TYPE: COMMERCIAL AND SUBSISTENCE

SPECIES: SPOT SHRIMP (*Pandalus platycerus*)

ON/OFF RESERVATION: OFF

EFFECTIVE DATES: JULY 24 THROUGH SEPTEMBER 15, 2024

DAYS/HOURS: FOR THE PORT GAMBLE S'KLALLAM AND JAMESTOWN S'KLALLAM TRIBES:

1. FOR QUOTA AREAS 1A, 1B, 2W AND 23A WEST: CLOSED
2. FOR QUOTA AREA 23A EAST: **OPEN 11:00 AM THROUGH 4:00 PM FRIDAY, JULY 26.**

GEAR RESTRICTIONS:

1. AS PER REGULATION #S24-026, SECTION 5
2. THE MAXIMUM TOTAL NUMBER OF POTS AND/OR RING NETS COMBINED PER VESSEL IN THIS FISHERY IS 25 FOR ALL QUOTA AREAS.
3. THE MINIMUM MESH SIZE FOR SHRIMP POTS AND RING NETS IS ONE INCH, AS DEFINED IN REGULATION #S24-026, SECTION 5, EXCEPT FOR FLEXIBLE (WEB) MESH POTS, FOR WHICH THE MESH MUST BE A MINIMUM OF 1 3/4 INCH STRETCH MEASURE. THERE IS NO MINIMUM MESH SIZE FOR ENTRY TUNNELS, BUT TUNNELS CAN ONLY BE LOCATED ON THE SIDES OF THE POTS.
4. ALL POTS AND RING NETS SHALL HAVE BUOYS ATTACHED. BUOYS MAY BE ANY COLOR EXCEPT YELLOW OR ANY COMBINATION OF RED AND WHITE. BUOYS MUST REMAIN FLOATING AT ALL TIMES EXCEPT DURING EXTREME TIDES. BUOYS WILL ALSO BE MARKED WITH THE TRIBE'S INITIALS AND WITH THE FISHER'S ID NUMBER. BUOY LINES WILL BE WEIGHTED TO KEEP THE LINES FROM FLOATING.

HARVEST RESTRICTIONS:

1. THE LEGALLY REGISTERED FISHERS IN QUOTA AREA 23AE FOR THE JAMESTOWN S'KLALLAM TRIBE ARE AS FOLLOWS:
 - a. GARY PETERSON, VESSEL #WN-352-JST;
 - b. JOSH CHAPMAN, VESSEL #WN-777-JST;
 - c. MATTHEW CHAPMAN, VESSEL #WN-170-JST;
2. THE LEGALLY REGISTERED FISHERS IN QUOTA AREA 23AE FOR THE PORT GAMBLE S'KLALLAM TRIBE ARE AS FOLLOWS:
 - a. JOHN AIKMAN, VESSEL #WN-595-PGK;
 - b. CASSANDRA SULLIVAN, VESSEL #WN-511-PGK;
 - c. MATT OLIVER, VESSEL #WN-369-PGK;
3. THE DAILY SUBSISTENCE HARVEST LIMIT IS 20 LBS PER FISHER.
4. ALL FISHERS MUST BE REGISTERED FOR THIS FISHERY WITH THEIR RESPECTIVE TRIBAL FISHERIES OFFICE BEFORE PARTICIPATING IN THE FISHERY. FISHERS MAY NOT FISH IN ANY CATCH MANAGEMENT AREA OTHER THAN THE ONE THAT THEY ARE REGISTERED FOR.
5. FISHERS MUST ADHERE TO ANY TRIBAL SOCIAL DISTANCING PROTOCOLS WHILE AT THE BOAT LAUNCH AND ON THE WATER.

HARVEST REPORTING:

1. AS PER REGULATION #S24-026, SECTION 8.
2. ALL DAILY HARVEST INFORMATION WILL BE REPORTED TO THE RESPECTIVE TRIBAL FISHERIES OFFICE WITHIN 24 HOURS OF EACH HARVEST. HARVEST INFORMATION SHALL INCLUDE THE DATE, VESSEL NAME, NUMBER OF POTS, MESH SIZE, POT SOAK TIMES, CATCH AREA, LOCATION FISHED, POUNDS LANDED BY SPECIES AND TOTAL POUNDS LANDED. HARVEST INFORMATION WILL BE UPLOADED ON THE NWIFC TICKET DATABASE WITHIN 7 DAYS OF REPORTING.
3. ALL COMMERCIAL AND SUBSISTENCE CATCHES SHALL BE REPORTED ON TREATY INDIAN FISH RECEIVING TICKETS AS SPECIFIED IN TRIBAL FISHERIES ORDINANCES. ALSO, ALL COMMERCIAL SHRIMP POT LANDINGS MUST BE RECORDED ON RECEIVING TICKETS AS WHOLE WEIGHT.
4. ALL COMMERCIAL SHRIMP SALES INTENDED FOR RESALE MUST BE MADE TO TRIBALLY APPROVED BUYERS WHO HAVE FILLED OUT A BUYER'S AGREEMENT WITH EITHER THE PORT GAMBLE OR JAMESTOWN TRIBE.
5. JAMESTOWN TRIBAL BUYERS MUST RETURN COMPLETED FISH TICKETS INTO JAMESTOWN'S FISHERIES OFFICE NO LATER THAN 6 DAYS FOLLOWING COMMERCIAL HARVEST.

EXPECTED HARVEST:

DURING THE TERM OF THIS REGULATION THE EXPECTED HARVEST WILL NOT EXCEED THE FOLLOWING TOTALS FROM ALL TRIBES COMBINED:

1. FOR QUOTA AREA 1A – 40,000 POUNDS
2. FOR QUOTA AREA 1B – 4,765 POUNDS
3. FOR QUOTA AREA 2W – 7,500 POUNDS
4. FOR QUOTA AREA 23AW – 20,000 POUNDS
5. FOR QUOTA AREA 23AE – 17,768 POUNDS

JUSTIFICATION:

CONTINUE HARVEST OF THE TREATY SHARE OF SHRIMP IN THE STIPULATED MANAGEMENT AREAS OF REGIONS 1, 2W AND 3. THIS REGULATION SETS NEW DATES AND HOURS FOR QUOTA MANAGEMENT AREA 23AE.
