DAYS/HOURS:

 FOR THE PORT GAMBLE S'KLALLAM TRIBE AND THE JAMESTOWN S'KLALLAM TRIBE, THE FISHERY WILL OPEN THURSDAY, APRIL 17 AND CONTINUE THROUGH MONDAY, JUNE 30, PROVIDED THAT THE FISHERY FOR EACH TRIBE MAY CLOSE SOONER IF THE INDIVIDUAL TRIBAL TARGET HARVEST IS TAKEN PRIOR TO THIS DATE.

2. DAILY OPENINGS WILL ONLY OCCUR FROM SUNRISE TO SUNSET EACH DAY.

GEAR RESTRICTIONS:

- 1. AS PER REGULATION #S25-023, SECTION 5
- THE MAXIMUM ALLOWABLE TOTAL NUMBER OF POTS AND/OR RING NETS COMBINED, IS 3
 POTS PER VESSEL. SHRIMP POTS REGISTERED TO A PARTICULAR VESSEL MUST BE SET AND
 PULLED BY THAT VESSEL, UNLESS OTHERWISE APPROVED BY THE RESPECTIVE TRIBAL
 FISHERIES OFFICE.
- 3. LONG LINES ARE ALLOWED IN THE HOOD CANAL SHRIMP FISHERY, PROVIDED THAT ALL LONG LINES AS WELL AS SINGLE POTS AND RING NETS SHALL HAVE BUOYS ATTACHED. BUOYS ATTACHED TO GEAR USED FOR EITHER SUBSISTENCE OR COMMERCIAL PURPOSES SHALL BE ANY COLOR EXCEPT YELLOW OR A COMBINATION OF RED AND WHITE. EACH BUOY SHALL BE CONSPICUOUSLY MARKED WITH THE INITIALS OF THE FISHER'S TRIBE (PG FOR PORT GAMBLE, JT FOR JAMESTOWN) FOLLOWED BY THE TRIBAL IDENTIFICATION CARD NUMBER OF THE FISHER OPERATING THE GEAR. THE BUOY SHALL ALSO BE MARKED WITH THE NUMBER OF POTS ATTACHED. EACH BUOY SHALL BE MARKED IN SUCH A WAY THAT THE FISHER, TRIBAL AFFILIATION AND NUMBER OF ATTACHED POTS CAN BE

IDENTIFIED WITHOUT REMOVING THE GEAR FROM THE WATER.

HARVEST RESTRICTIONS:

- 1. ALL FISHERS WISHING TO FISH FOR SUBSISTENCE MUST OBTAIN A SUBSISTENCE PERMIT FROM THE THEIR RESPECTIVE TRIBAL FISHERIES OFFICE. SUBSISTENCE PERMITS WILL BE VALID ONLY FOR THE TIME AND DATE SPECIFIED ON THE PERMIT. ONCE A PERMIT BECOMES INVALID, A NEW PERMIT WILL BE REQUIRED FOR ADDITIONAL SUBSISTENCE FISHING. TRIBAL FISHERY OFFICES MAY PLACE A RESTRICTION ON THE NUMBER OF SUBSISTENCE PERMITS ALLOWED.
- 2. OVERNIGHT SOAKS ARE NOT PERMITTED. ALL POTS MUST BE REMOVED FROM THE WATER BY SUNSET EACH DAY.
- 3. FOR THE PORT GAMBLE S'KLALLAM TRIBE AND THE JAMESTOWN S'KLALLAM TRIBE, THE DAILY SUBSISTENCE LIMIT IS 20 POUNDS OF SHRIMP PER PERMITTED FISHER. NO MORE THAN TWO PERMITTED FISHERS PER BOAT.
- 4. ALL FISHERS MUST ADHERE TO THEIR RESPECTIVE TRIBAL SOCIAL DISTANCING PROTOCOLS WHILE AT THE BOAT LAUNCH AND ON THE WATER.

HARVEST REPORTING:

ALL TRIBAL SUBSISTENCE FISHERS MUST REPORT THEIR CATCH IN ACCORDANCE WITH THE REQUIREMENTS OF THEIR RESPECTIVE FISHERIES OFFICE.

PROJECTED HARVEST:

THE MAXIMUM HARVEST LIMIT FOR THIS FISHERY IS 700 POUNDS EACH FOR PORT GAMBLE AND JAMESTOWN. THE FISHERY WILL CLOSE FOR EITHER TRIBE PRIOR TO JUNE 30 IF THE INDIVIDUAL TRIBAL QUOTA HAS BEEN TAKEN BEFORE THIS DATE.
